

## 2026 NRPA Annual Conference Sweepstakes Rules and Restrictions:

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE CONTEST. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility:** Sweepstakes (the “Sweepstakes”) is open only to those who sign up at the online sweepstakes page and who are age 18 or older as of the date of entry. The sweepstakes is only open to legal residents of the United States and is void where prohibited by law. The contest is not open to National Recreation and Park Association officers, board members or employees, or their immediate relatives. “Immediate relatives” includes only parents, siblings and their spouses, and natural or adopted children and grandchildren of the individual or his or her spouse. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.
- 2. Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of the National Recreation and Park Association, as final and binding as it relates to the content. The Sweepstakes is subject to all applicable federal, state and local laws.
- 3. Sweepstakes Period:** Entries will be accepted online starting on or around Friday, March 27, 2026, and ending May 10, 2026. All online entries must be received by May 10, 2026, at 11:59 p.m. EDT.
- 4. How to Enter:** The Sweepstakes must be entered by submitting an entry using the online form here: <https://conference.nrpa.org/sweepstakes/>. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the National Recreation and Park Association. **Limit of one (1) entry per person** and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent

the rules, your submission may be removed from eligibility at the sole discretion of the National Recreation and Park Association.

5. **Prizes: One (1) grand prize package will be awarded**, which consists of: one (1) 2026 NRPA Annual Conference Full Package Registration (including education sessions, daily admission to the exhibit hall and access to the virtual conference), three (3) nights in a Philadelphia hotel within the official NRPA housing block at NRPA's discretion, and a \$500 Visa gift card for travel/airfare expenses. **Two (2) runner-up prizes will be awarded**, which each consist of: one (1) on-demand access to the virtual 2026 NRPA Annual Conference.
  
6. **Prize Conditions:** The National Recreation and Park Association reserves the right to choose the appropriate registration package, the hotel and the type of room for the grand prize winner. Actual/appraised value may differ at time of prize award. The specifics of the prizes shall be solely determined by the National Recreation and Park Association. No cash or other prize substitution permitted except at the National Recreation and Park Association's discretion. If the grand prize winner is unable to attend the in-person conference for any reason, the \$500 Visa gift card for travel/airfare expenses will be forfeited and will not be awarded in any form. The prizes are nontransferable. Any and all prize-related expenses, including and without limitation of any and all federal, state and/or local taxes, shall be the sole responsibility of the winner. Acceptance of prizes constitutes permission for the National Recreation and Park Association to use winner's name, likeness and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
  
7. **Odds:** The odds of winning depend on the number of eligible entries received.
  
8. **Winner selection and notification:** Winners of the Sweepstakes will be selected in a random drawing under the supervision of the National Recreation and Park Association. Winners will be notified via email to the email address they entered the Sweepstakes with within five (5) days following the winner selection. The National Recreation and Park Association shall have no liability for a winner's failure to receive notices due to winners' spam/junk email or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and

releases as required, prize may be forfeited and an alternate winner selected. The receipt by winner of the prize offered in this Sweepstakes is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT THE NATIONAL RECREATION AND PARK ASSOCIATION'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE SWEEPSTAKES AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

9. **Rights Granted by you:** By entering this contest you understand that the National Recreation and Park Association, anyone acting on behalf of the National Recreation and Park Association, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Sweepstakes, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.
  
10. **Terms:** The National Recreation and Park Association reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Sweepstakes should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Sweepstakes. In such case, the National Recreation and Park Association may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by the National Recreation and Park Association. The National Recreation and Park Association reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or website or violates these Terms & Conditions. The National Recreation and Park Association has the right, in its sole discretion, to maintain the integrity of the Sweepstakes, to void votes for any reason, including, but not limited to; multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by sweepstakes rules; or the use of bots, macros or scripts or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the sweepstakes

may be a violation of criminal and civil laws and should such an attempt be made, the National Recreation and Park Association reserves the right to seek damages from any such person to the fullest extent permitted by law. By entering the Sweepstakes you agree to receive email newsletters periodically from the National Recreation and Park Association. **11. Limitation of Liability:** By entering you agree to release and hold harmless the National Recreation and Park Association and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in the sweepstakes and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof, (ii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software; (iii) the unavailability or inaccessibility of any transmissions or telephone or internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error which may occur in the administration of the Promotion or the processing of entries.
